#### 1.1 PROJECT INFORMATION

- A. Notice to Bidders: Prequalified bidders are invited to submit bids for Project as described in this Document.
- B. Project Identification: Forster Building

- E. Project Description:

The project consists of facade renovations to a mixed-use structure built in 1910 +/-. The building has three stories of commercial occupancy on the first, second and third floors.

Plans illustrate renovations and repairs to the commercial facade. These renovations include the installation of new windows, standing seam roof, fixed operable doors, main entrance doors fabric awnings and signage.

Repairs include cornice restoration, scored stucco and painting. The interior vestibule on the first floor will be renovated and leveled to match interior elevations on the first floor commercial space.

#### 1.2 BID SUBMITTAL AND OPENING

- B. Bids will be thereafter privately opened.

#### 1.3 DOCUMENTS

A. Printed Procurement and Contracting Documents: Obtain on or after Monday, November 21, 2016 at Roxborough Development Corporation 6111 Ridge Avenue, Philadelphia, PA 19128. The Documents are available for pick-up between the hours of 10:00am and 6:00pm. Two copies of the Documents will be provided to prime bidders only; only complete sets of documents will be issued. Shipping the documents in not an option.

#### 1.4 SITE VISIT

A. Bidders are required to visit the site prior to submitting a bid. James Calamia Executive Director from the RDC are available to facilitate a walk-through of the building. Call the RDC office at 215-508-2358, 6111 Ridge Avenue, 48 hours ahead to announce arrival time, between 10am and 4pm Monday through Friday.

#### 1.5 BIDDER'S QUALIFICATIONS

- A. Bidders must be properly licensed under the laws governing their respective trades and be able to obtain insurance and bonds required for the Work.
- B. Complete the attached Contractor's Qualifications Statement.

#### 1.6 PERMIT APPLICATION INFORMATION

A. Permit Application: Complete and file neccessary Applications for Permit and other related Applications for Building Permit with authorities having jurisdiction within five days of the Notice to Proceed.

#### 1.7 INSURANCE REQUIREMENTS

- A. Bidders are required to provide proof of the following insurance:
  - 1. Worker's Compensation: Statutory Limits
  - 2. Comprehensive General Liability (including products and completed operations): Minimum limit of \$1,000,000 per Occurrence and \$2,000,000 aggregate general liability.
  - 3. Automobile Liability Insurance: Minimum limit of \$300,000.

#### 1.8 TIME OF COMPLETION

- A. Bidders shall begin the Work on receipt of the Notice to Proceed and shall complete the Work within the Contract Time.
- B. Submit a proposed timeline schedule listing start, completion, and major milestone dates with Bid.

#### 1.9 CONTRACT AGREEMENT

- A. The Owner will utilize the American Institute of America (AIA) contract agreements. Contract negotiations will be based on:
  - 1. A101-2007 Standard Form of Agreement between Owner and Contractor where the basis of payment is a Stipulated Sum.
  - 2. A201-2007 General Conditions of the Contract for Construction.

#### 1.10 WAIVER OF LIENS

A. Neither Contractor nor any subcontractor furnishing labor or materials to Contractor in connection with the Project shall file mechanics' notices of intention or stop notices, or file or otherwise assert any liens against the Project or the Site. Each subcontract entered into by Contractor shall contain similar provisions whereby the subcontractor expressly waives and is prohibited from filing or asserting liens, notices of intention, or stop notices.

#### 1.11 AWARD OF CONTRACT

- A. The Owner will evaluate bids in response to this solicitation and will award a contract to the responsible bidder whose bid, conforming to the solicitation, will be most advantageous to the project. Cost or price and other factors will be considered.
- B. The Owner reserves the right to reject any and all offers, to waive technical defects or any informality in offers if, in his/her judgment, the best interest of the project is served.










2 PROPOSED PLAN AT FOYER
